

Where is Sao Tome & Principe located?

The Republic of Sao Tome and Principe (STP) is an archipelago 350 km off the west coast of Africa in the Gulf of Guinea, composed of six districts and the Autonomous Region of Príncipe (Região Autónoma do Príncipe). A Portuguese-speaking country, it has a population of about 225,000 (2021).
