

Who is Efacec Power Solutions SGPS?

EFACEC Power Solutions SGPS, S.A. is a Portuguese energy, engineering and mobility company, comprising several subsidiaries in different international markets. Efacec group is one of the largest manufacturers in the fast-charging infrastructure market for electric vehicles.

Who owns Efacec Power Solutions?

In October 2015, the company Winterfell Industries acquired the majority of the capital of Efacec Power Solutions. The former shareholders - Jos de Mello and Txtil Manuel Gonalves Groups - now hold a minority position in the company's capital and new Governing Bodies were elected. 2020 was a year of shareholder change for Efacec.

Why did Efacec change its name to EPS?

On August 14, 2014, we changed our name to Efacec Power Solutions, S.A. (EPS). The constitution of EPS was part of the restructuring process that Efacec Capital, SGPS, S.A. started at the end of 2013, intending to align the corporate structure of the Efacec Group with the market segments addressed and the target geographies.

Where is Efacec based?

With a strong expertise around energy transition, the company is headquartered in Matosinhos with industrial facilities in Maia (Porto/Portugal), employing more than 2,000 people. With a global presence, Efacec delivers innovative technologies and high-quality products in energy systems, engineering services, and electric mobility infrastructure.

Where did Efacec come from?

Efacec emerged in 1948, from the union of the Belgian group ACEC (Ateliers de Constructions lectriques de Charleroi) and CUF (Companhia Unio Fabril), one of the largest Portuguese business groups at the time. The Efacec project history begins, however, in 1905, with the foundation of a new company named Modern Mechanical Sawing Society.

With strong R&D capabilities, Efacec is at the forefront of technological advancements. Overall, Efacec is a renowned company poised to drive positive change in critical infrastructure within the energy transition and circular economy.
