Regarding the gas sector reforms, Moldova has adopted several regulations, including the network code and market rules, as a step towards the establishment of a competitive gas market.

Does Moldova have a low emissions strategy?

Moldova is also one of the first countries in the EU4 Energy region 4 that has pledged (by a Government decree adopted in December 2019) to develop, by 2022, a new mid-century Low Emissions Development Strategy, outlining the policies for accelerating GHG reductions by 2050.
