Why is a first article inspection a 'report'?

Documenting first article inspections properly in the form of a 'report' is critical to ensuring that products do meet specifications, and that in the event of one or multiple non-conformances, the purchaser and supplier have both inspected and signed off on to prevent or reduce disputes.

What is the energy storage safety strategic plan?

Under the Energy Storage Safety Strategic Plan, developed with the support of the U.S. Department of Energy (DOE) Office of Electricity Delivery and Energy Reliability Energy Storage Program by Pacific Northwest Laboratory and Sandia National Laboratories, an Energy Storage Safety initiative has been underway since July 2015.

Can CSRS be applied to energy storage systems?

Recording Inspection Results AOs undertaking empty container inspections must ensure that the inspection process is fully documented. Inspection details must be recorded on an approved inspection record. Original inspection records must be retained for at least 2 years and be available for auditing and verification.

Quality Inspector provides an example First Article Inspection Report 3 (FAIR Form 3) to assist with sites that require additional reporting for AS9102 or similar standards. First Article Inspection Form 3 is the Characteristic Accountability, Verification, and Compatibility Evaluation form. Note: A first article inspection typically refers to the produce used in the first inspection

preparation, execution (covering inspection and verification activities) and documentation of the First Article Inspection (FAI) necessary to comply with the requirements of ISO/TS 22163. FAI applies to internal and external products to release serial production, the validation of production equipment and the production processes.
