

Is Fulcrum BioEnergy going under?

(Bloomberg) -- Fulcrum BioEnergy, a clean-fuels pioneer that raised more than \$1 billion to turn household waste into lower-emitting fuels for planes and trucks, is in danger of going under. The company recently laid off nearly all of its staff of about 100 and halted most of its operations, according to more than a half-dozen former employees.

Does fulcrum have a fuel diversification strategy?

Fulcrum was at one time touted by energy company BP, an investor, as an example of the company's fuel diversification strategy. None of those companies responded to requests for comment. While Fulcrum's plant floundered, the alternative fuels sector has continued to pursue other innovations.

Why is Fulcrum BioEnergy teetering on the brink of collapse?

This term might be appropriate for describing the situation faced by Fulcrum BioEnergy's ambitious endeavour to convert household waste into sustainable fuel for aviation and trucking which has faced significant setbacks and is teetering on the brink of collapse.

How much fuel does Fulcrum produce a year?

Fulcrum's Nevada plant, which was supposed to produce 11m gallons of fuel annually, represents a significant gap in the projected supply chain. As a comparison, that would represent around 30% of the UK's SAF mandate for 2025 assuming aviation fuel consumption remained constant between 2021 and 2025.

Is Fulcrum the future of transportation fuels?

Since the company launched in 2007, Pleasanton, California-based Fulcrum has been heralded as a key player in the broader quest to develop new sources of cleaner transportation fuels. One of the key roadblocks is finding inexpensive feedstocks that can generate vast quantities of fuel with fewer heat-trapping emissions.

Will Fulcrum turn garbage into fuel?

Fulcrum, though, has consistently struggled to deliver on its vision. When the New York Times reported in 2008 about companies seeking to turn garbage into fuels, it mentioned that Fulcrum planned to begin operating its Nevada plant by 2010.
