

Who owns Kuwait Energy plc?

Kuwait Energy plc (KE) is United Energy Group's(UEG) subsidiary and has oil and gas assets in the Middle East and North Africa (MENA) region. KE was established in 2005 and acquired by UEG in March 2019. KE has built a high-quality,diversified portfolio of oil and gas assets across Iraq and Egypt.

Does Kuwait have oil and gas companies?

While Kuwait's oil and gas sector is also home to non-government owned companies,their operations are largely outside of the country. For instance,Kuwait Energy is a subsidiary of Hong Kong-listed United Energy Group,which maintains exploration,development and production assets in Iraq,Egypt,Oman and Yemen.

Founded in 2005,Kuwait Energy is said to have a diversified portfolio of oil and gas assets. The company is engaged in exploration,appraisal,development and production of hydrocarbonsacross Iraq,Egypt,Yemen and Oman.
