

Who owns sound energy Morocco east limited?

RABAT, June 14 (Reuters) - UK gas company Sound Energy PLC (SOU.L) sold its subsidiary, Sound Energy Morocco East Limited, to Morocco's largest mining company, Managem, the two companies said on Friday.

What happened to sound energy Morocco east?

Sound Energy has confirmed the completion of the transaction for the partial divestment of its Moroccan assets through the sale of its entire issued share capital in Sound Energy Morocco East to Managem, for a total value of up to \$45.2m (£35.65m). The terms of the sale and purchase agreement were disclosed by the company on 14 June 2024.

What is a sound energy Morocco east agreement?

The agreement includes a contingent production payment and reimbursement for past expenditures incurred by Sound Energy Morocco East (SEME). Sound Energy will provide transitional support to Managem to ensure a smooth handover of operations.

Sunda Energy Plc Ord 0.025p is listed on the London Stock Exchange trading with ticker code SNDA.L. It has a market capitalisation of £17.86m, with approximately 25.51b shares in issue. Over the last year, Sunda Energy share price has been traded in a range of 0.0925, hitting a high of 0.1425, and a low of 0.05.

How much gas does Morocco need?

Morocco imports most of its gas needs, estimated at 1 billion cubic meters (bcm) currently, enough to power two small stations in its northwest and northeast. Its gas needs are expected to grow to 8 bcm as the country seeks to reduce its carbon footprint, according to energy ministry estimates. [Sign up here.](#)

How many cubic meters a year will Morocco's gas field produce?

The field is expected to start production at 100 million cubic meters annually starting next year, Managem said in a statement. Managem plans to further increase production there to 280 million cubic meters, when the field will be connected to an existing gas pipeline that connects Morocco to Spain, Managem added.
