Beneficiaries can apply for the scheme online through the National Portal for Rooftop Solar. Once installed, the surplus electricity generated can be sent back to the power grid, allowing users to earn credits on their electricity bills.

Who launched the national portal for rooftop solar?

Hon'ble Prime Minister of India, Shri Narendra Modi launched the National Portal for Rooftop Solar on 30/07/2022. Shri R. K. Singh, Union Minister for Power and NRE and Shri Krishan Pal Gurjar, MoS, Power and Heavy Industries were present. Shri Bhagwanth Khuba, MoS, MNRE joined virtually.

This scheme will help the government save around Rs. 75,000 crore per year for electricity costs.
