

**What is BNRG Renewables?**

BNRG Renewables is an international Renewable Energy development company headquartered in Dublin, Ireland. The company has projects under development in seven countries. Specializing in utility-scale solar PV projects, BNRG Renewables' work covers all aspects of development including site assessment, obtaining planning and grid connection rights.

**How many solar projects will bnrg build in 2028?**

In addition to our operating portfolio, we are on track to construct 1.9 GW of new solar projects by end 2028 in four major markets. BNRG entered the US market in 2016 and we've successfully completed a portfolio of projects in Oregon totalling 29 MW. We're currently constructing a 448 MW portfolio in Maine.

**Does bnrg have a solar development pipeline?**

BNRG currently has a solar development pipeline of 2.7 gigawatts across Ireland, the US, UK and Australia. **When did bnrg renewables close?**

BNRG Renewables last closed a funding round on Dec 20, 2022 from a Convertible Note round. BNRG Renewables is an international Renewable Energy development company based in Dublin. Possible competitors to BNRG Renewables may include Rockstart, Q2Power, and ENGIE.

**Will bnrg build a solar farm in Kildare & Cork?**

BNRG is delighted to announce the commencement of construction on three solar farms in Kildare and Cork with our venture partners Impax Asset Management. These projects have a combined capacity of 43 MWp which will power 10,000 homes in Ireland with solar by 2025.

**Where is bnrg constructing a portfolio?**

We're currently constructing a 448 MW portfolio in Maine. We're at home in Ireland and we've been developing there since 2015 to deliver a portfolio of 313 MW with the first phase to be constructed in 2024. BNRG successfully developed and constructed over 100 MW of projects under the UK's Feed-In Tariff and Renewable Obligation Certificate schemes.
