What is the 'guidance' for the energy storage industry?

What is the 'guidance on accelerating the development of new energy storage?

What are the requirements for a CHP electric generator?

A CHP electric generator must be a synchronous generator, not an induction generator that requires the grid power signal for operation.\n\nHigh frequency generators (microturbines) or direct current (DC) generators (e.g.,fuel cells)need to have inverter technology that can operate independently from the grid.

How can management and guidance improve energy management?

Through strengthening management and guidance, it can effectively standardize industry management, optimize industrial layout, improve the efficiency of energy storage systems, and avoid disorderly development of the industry.
