

Why did St Helena government create a company?

Creation of the Company was a catalyst to move non-core areas of St Helena Government into the private sector as part of a divestment programme. The Company is owned by the St Helena Government and came into operation on 1 April 2013.

Why does St Helena have less fuel tankers?

With fuel demand expected to increase due mainly to airport-enabled tourism, the limiting factor preventing St Helena from achieving economies of scale through larger, less frequent fuel tanker shipments was the volume of available ground fuel storage.

How many staff does connect Saint Helena have?

We currently employ over 70 staff. Connect Saint Helena Ltd provides three core services, namely Electricity, Water and Wastewater. These core services are supported by finance and administration functions. A Projects team co-ordinates our capital programme. The Company is regulated by the St Helena Utilities Regulatory Authority.

What is a connect Saint Helena microgrid?

The agreement with Connect Saint Helena Ltd includes a microgrid for the South Atlantic island that combines a 568 kWp/500 kW solar farm; a three-turbine, 2.7 MW wind farm; and a 3.2 MWh/3.5 MW battery.

Travel restrictions caused by the COVID-19 pandemic resulted in lower numbers of visitors on St Helena -both St Helenian and non-St Helenian. But, from the 2020/21 Christmas holiday season into 2021 to present, there was a higher number of visitors arriving, with the 2021/22 and 2022/23 holiday seasons showing a more typical pattern.
