As the country has high solar irradiation, solar PV has been the focus area within renewables for the government. By 2030, cumulative solar PV capacity in Saudi Arabia is expected to reach 28.6GW, growing from 0.5GW in 2020.

What is open solar contracts?

The Open Solar Contracts initiative, supported by multiple reputable law firms, will provide a standardised contractual documentation solution that will be freely and publicly available and is designed to be universally applicable.

Where are the PV plants located in Saudi Arabia?

The tendered PV plants include the 2 GW (AC) Al Sadawi plant located in the country's east and the 1 GW (AC) Al Masa'a project located in northern Hail province. It also includes the 400 MW (AC) Al Henakiyah 2 plant located in western Madinah province and the 300 MW (AC) Rabigh 2 array located in western Makkah province.

Who are the bidders for the 1000 MW Al-Masaa project?

The shortlisted bidders for the 1,000 MW Al-Masaa Project (1000 MW) are the SPIC Huanghe Hydropower Development-EDF Renouvelables consortium, which offered \$0.0131/kWh, and Saudi-based Al Jomaih Energy and Water Company in partnership with the renewable energy arm of French giant Total Energies, which submitted a price of \$0.0136/kWh.
