

Who owns a solar farm in Sicily?

Image source: Sonnedix Power Holdings (handout) Sonnedix Power Holdings Ltd announced on Friday that it has acquired an 80-MW solar farm in Sicily from Italian renewables developer Blunova SpA as part of their broader deal involving the sale of 250 MW of operational capacity located in southern Italy.

What is a 'largest' solar project financing deal in Italy?

The financing includes a greenfield project finance agreement for two PV plants in Sicily and Sardinia, with a combined capacity of around 200MW. It was agreed in December 2023 and represents one of the "largest solar project financing deals in the Italian market", Sonnedix said.

Is Sonnedix expanding its solar power capacity in Italy?
