Will ejecting Russian banks from Swift affect the economy?

None of this is to say that there will be no economic impact in ejecting Russian banks from Swift. It will affect lower value payments, such as those in small business supply chains, because Swift makes payments processing so cheap and easy.

Will the EU sanction Russia through swift?

Getting the EU on board for sanctioning Russia through SWIFT had been a tough process since EU trade with Russia amounted to 80 billion euros, about 10 times as much as the United States, which had been an early proponent of such measures. Germany specifically had balked at the measure since it could hit them hard.

The aim is for Russian companies to lose access to the normal smooth and instant transactions provided by Swift, disrupting payments for its valuable energy and agricultural exports.

Vladimir Putin's declaration of war on Ukraine has revived calls to kick Russia out of Swift. The measure is seen as among the most severe that the US, EU and UK could take.

In 2019, the European Union imported 88 billion euros worth of energy from Russia, and it is set to exceed that amount for 2021. For reference, the Russian annual military budget is approximately \$60 billion USD. It is not a stretch to say that the European Union's imports of Russian energy are sustaining Russia's war effort against Ukraine.
