What is Poland's energy storage subsidy program?

Following a public consultation launched in July 2024, the Polish Ministry of Climate and Environment has finalized its energy storage subsidy program which aims to support the deployment of more than 5 GWhof energy storage in the country. The new regulation was published in the Journal of Laws of the Republic of Poland on March 7.

What is the European Commission subsidy scheme?

The European Commission authorized the subsidy scheme in October 2024 to the tune of EUR1.2 billion in a bid to support the installation of at least 5.4 GWh of new electricity storage facilities.

How will the European Commission support large-scale energy storage in Spain?

The European Commission on Monday approved a new aid scheme for the deployment of large-scale electricity storage in Spain. Subsidieswill be available for standalone energy storage sites, projects installed alongside renewable energy facilities, and storage planned as part of thermal power plants.

How much PLN will be distributed under the energy subsidy scheme?

A total of PLN 4 billion(\$1 billion) will be distributed under the subsidy scheme by the end of 2025 in a bid to bring online more than 5 GWh of energy storage projects by 2028.

What is the European energy storage inventory?

In March 2025,the Commission launched the European Energy Storage Inventory,a real-time dashboardthat displays energy storage levels across different European countries. It is the first European-level tool of its kind and offers energy storage data across a full range of technologies.

What is the energy storage scheme?

The scheme has been approved in accordance with the Temporary Crisis and Transition Framework for State aid measures, adopted by the Commission on 9 March 2023 and amended on 20 November 2023 and 2 May 2024. The objective of the scheme is to provide investment aid for the deployment of large-scale energy storage.

Under this scheme, the aid, partially financed by the European Regional Development Fund (ERDF), will take the form of direct subsidies to support the construction of ...
