What is the implementation plan for the development of new energy storage?

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.

How will new energy storage technologies develop by 2030?

By 2030, new energy storage technologies will develop in a market-oriented way. Newer Post NDRC and the National Energy Administration of China Issued the Medium and Long Term Development Plan for Hydrogen Industry (2021-2035)

How has energy storage been developed?

Energy storage first passed through a technical verification phase during the 12th Five-year Plan period, followed by a second phase of project demonstrations and promotion during the 13th Five-year Plan period. These phases have laid a solid foundation for the development of technologies and applications for large-scale development.

How has energy storage changed over 20 years?

As can be seen from Fig. 1, energy storage has achieved a transformation from scientific research to large-scale application within 20 years. Energy storage has entered the golden period of rapid development. The development of energy storage in China is regional. North China has abundant wind power resources.

How is energy storage developing in China?
