Is Morocco dependent on Western Sahara for its energy supply?

But these developments have made Morocco partly dependenton Western Sahara for its energy supply. Morocco already gets 18% of its installed wind capacity and 15% of its solar from the occupied territory, and by 2030 that could increase to almost half of its wind and up to a third of its solar.

Is the Sahara based on economic resources?

The idea of the economic viability of the SADR being based on its economic resourcesis also found in Shelley (2004) and echoed by MINURSO and UN Special Envoy to the Sahara, James Baker. Kingsbury (2015) establishes that Western Sahara is illegally and militarily occupied by Morocco.

Is natural resource exploitation a problem in Western Sahara?

As the issue of natural resource exploitation in Western Sahara has been conceptualised in very different ways and from the perspectives of a variety of disciplines, the authors have opted for a semi-systematic review of the work done encompassing academic, non-academic, and activist backgrounds.

What role did natural resources play in the Western Sahara conflict?

The majority of research undertaken from a historical perspective on the role of natural resources in the Western Sahara conflict focuses on phosphates. Both Lalutte (1976) and Camprubí (2015) see the potential exploitation of phosphates as the key factor in motivating Morocco to invade Western Sahara.
